• UK competition regime reform (2016)

Led the National Audit Office's assessment of the new UK competition regime, including the establishment of the Competition and Markets Authority, concluding that the new regime had increased coherence, but had not yet produced a substantial flow of enforcement decisions or fines.

• Water regulation (2015)

Led the National Audit Office's report on GB water regulation, assessing the cost of capital, incentive mechanisms and approaches to service quality. This led to significant changes to the regulatory regime, for instance in the treatment of debt costs.
