BIOGRAPHY

Yvette Austin is a Senior Managing Director and Chair of the Compass Lexecon Global Finance Practice. Over her 30-year career, Ms. Austin has developed expertise in a wide range of financial and economic areas. With subject matter expertise in valuation, credit and solvency analysis, and other financial damages, she has been retained as a testifying and consulting expert to analyze and quantify damages and other types of liability in disputes involving mergers and acquisitions, bankruptcy, breach of representation and warranties, breach of fiduciary duty, financial fraud, material adverse effect, dissenting shareholder actions, leveraged buyouts, debt recharacterization, avoidance actions, liability management transactions, antitrust damages and trade disputes. Ms. Austin also regularly estimates the number and value of claims in mass torts. She has provided claims analysis and estimation in connection with claims arising from talc, opioids, asbestos, transvaginal mesh, breast implants and PFAS.
